

**HOGBACK METROPOLITAN DISTRICT
ANNUAL REPORT FOR REPORT YEAR 2024
JEFFERSON COUNTY, COLORADO**

Pursuant to the Consolidated Service Plans for Hogback Metropolitan District (the “District”) and pursuant to section 32-1-207(3)(c), C.R.S., the District is required to submit an annual report to the Clerk of the Board of County Commissioners no later than August 1 of each year. The District submits the following information below for the year 2024 (the “Reporting Year”).

During the report year of 2024, the Board of Directors did not make or propose any changes to the boundaries of the District.

The District did not adopt any rules or regulations in 2024.

The District is not currently and was not previously in the prior year a party to any litigation which involves the Public Improvements.

The District is not directly undertaking the construction of any Public Improvements, but the District is utilizing existing project funds to repay costs associated with Public Improvements constructed by third parties. The following is a summary of Public Improvements constructed within the District as of December 31 of the prior year:

Parcel A – Ken Caryl Ranch North Plains Filing 1

- Grading and Excavation – 100% complete
- Retaining Walls – 100% complete
- Storm Drainage – 100% complete
- Sanitary Sewer/Underdrain – 100% complete
- Water Lines – 100% complete
- Street Improvements – 98% complete

Parcel B – Ken Caryl Ranch North Plains Filing 2

- Grading and Excavation – 100% complete
- Retaining Walls – 99% complete
- Storm Drainage – 0% complete

- Sanitary Sewer/Underdrain – 3% complete
- Water Lines – 14% complete
- Street Improvements – 0% complete

Parcel C – Ken Caryl Ranch North Plains Filing 1 Adjustment 2

- Grading and Excavation – 95% complete
- Retaining Walls – 0% complete

- 6. A list of all facilities and improvements constructed by the Districts' that have been dedicated to and accepted by Jefferson County as of December 31 of the Reporting Year.**

The District is not directly undertaking the construction of any Public Improvements. Parcel A/Filing 1 storm drainage and street improvements were dedicated to and accepted subject to warranty reserves by Jefferson County as of December 31 of the report year.

The District assessed valuation for 2024 was \$6,422,317.
